

**Terms and Conditions of the Conference

We reserve the right to modify, cancel, or terminate the giveaway at any time without prior notice due to unforeseen circumstances, without participants having any claims against the organizer.

Prize delivery will take place as follows:

After prior notification of the address, the prize will be sent to the winner by post.

Participants are solely responsible for the accuracy of the contact details provided.

If a prize cannot be delivered, no further investigations regarding the participant will be conducted. If the winner does not respond within 10 days of the prize notification being sent, entitlement to the prize will expire.

Legal recourse is excluded.

The law of the Federal Republic of Germany shall apply exclusively.

Should individual provisions of these terms and conditions be invalid, the validity of the remaining provisions shall remain unaffected.

## **Data Protection Information**

### **1. Processing of Personal Data**

By participating in our giveaway, we collect your personal data (name, contact details, and email address) only to the extent provided by you. The processing of data serves the purpose of properly conducting the giveaway and notifying you in the event of a win.

This data processing is carried out on the basis of Article 6(1)(a) GDPR with your consent. You may withdraw your consent at any time by notifying us, without affecting the lawfulness of processing carried out on the basis of consent before its withdrawal. Your data will subsequently be deleted.

If you win, your data will be shared with a shipping company selected by us. No further transfer of data to third parties will take place.

### **2. Storage Period**

We store your personal data for as long as necessary to decide the outcome of the giveaway. Your data will then be deleted no later than three months afterward, unless you have consented to further processing and use and/or we have a legitimate interest in continued storage.

### **3. Rights of Data Subjects**

Provided the legal requirements are met, you are entitled to the following rights under Articles 15–20 GDPR: the right of access, rectification, erasure, restriction of processing, and data portability.

In addition, under Article 21(1) GDPR, you have the right to object to processing based on Article 6(1)(f) GDPR, as well as to processing for direct marketing purposes.

#### **Right to Lodge a Complaint with a Supervisory Authority**

Under Article 77 GDPR, you have the right to lodge a complaint with a supervisory authority if you believe that the processing of your personal data is unlawful.

#### **Right to Object**

Where the personal data processing listed here is based on our legitimate interest pursuant to Article 6(1)(f) GDPR, you have the right, on grounds relating to your particular situation, to object to such processing at any time with effect for the future.

After an objection has been made, processing of the affected data will cease unless we can demonstrate compelling legitimate grounds for processing that override your interests, rights, and freedoms, or unless the processing serves the establishment, exercise, or defense of legal claims.
